The nurturing environment of Small Steps provides students with a strong academic program and attention to the needs of the whole child. During 2014, Small Steps provided the following at no charge to 180 economically at-risk and inner-city children and their 146 families: Highly qualified and committed teachers who inspire learning; small classes that allow relationships to be nurtured; academic environments that are enriching and encourage children's imaginations; an innovative social-emotional curriculum that fosters self-esteem and respect; site-prepared meals that meet daily nutritional needs; staff-driven vans that provide dependable transportation to and from school; and an environment where each person is treated as a unique creation and deserving of God's grace. Program success has led to a demand for services that has consistently outpaced capacity, and Small Steps continues to receive approximately three applications for each space available. Small Steps completed the expansion of the Fifth Ward campus in 2013, which allowed an increase in the number of children served in the following school year, a 15% increase as compared to 2013 and a 50% increase as compared to 2012.
